

GB/01/22 Apologies for absence

The Executive Head was asked to find out if any parents might be interested in becoming a governor, with Mr Williams possibly moving to co-opted status.

GB/06/22 Summary of Headteacher's report and governors' questions and challenge

The Executive Head highlighted the following points from her report, which had been previously circulated:

- The intense start to the year due to covid. Also, the response of the staff of the two offices, who have worked above and beyond.
- Pupil numbers, where numbers are low in some year groups at Trent Vale, but nearly full in most year groups at Beeston Rylands.
- Attainment and Progress data a full summary has been uploaded onto governorhub.

The meeting was informed of the large number of social and emotional issues, which were hindering the progress of the children.

Details of support being offered were given.

A governor asked about the expected Phonics score – relative to previous years.

The Executive Head responded that the current Y2 is an "interesting" year group. The predicted score is likely to be lower than in previous years.

In preparation for this KS2 teachers had undertaken phonics training in order to ensure continuity in KS2.

Pupil Premium funding and progress of Disadvantaged Pupils.

Mrs Osborne informed the meeting of the successful tutoring programme which had been put into place. Feedback is very positive.

- Attendance, obviously adversely affected by covid. However, figures for both schools compare favourably to national figures.
- Behaviour, which is good at both schools.
- Details of safeguarding issues.
- Progress on the SIP.
- Curriculum, where details of monitoring undertaken were given.

A governor sought detail of the areas of strength of both schools.

- Staff absence.
- Teacher appraisals.
- Budgetary matters.

School budgets

Mrs Lievesley, School Finance Officer, is currently in school working on the 2022/23 budgets. She will be returning on 10 May 2022 to finalise both budgets.

These will be agreed at the next Resources Committee meeting 23 May 2022 – to be formally approved retrospectively at the next FGB meeting on 14 July 2022.

Governors asked if the school had any information on the "new builds" housing close to the school.

These could lead to a large increase in pupil numbers, with several year groups already being full.

Councillor Foale agreed to enquire at County Hall what plans are in place.

Year-end re-forecast

Currently Trent Vale is expecting a deficit of approximately £12k on the 2021/22 budget – but this is predicted to be removed by the end of 2022/23.

Beeston Rylands are predicted to have a surplus of £88k, but this includes £15k to be spent on the planned new trim trail.

This surplus is expected to fall to £32k by the end of the 2022/23 financial year.

These figures were formally approved by the meeting.
