# Excel, Enjoy, Be Proud

Dear parent/carer of children currently in Year 5,

#### <u>Yr6 Residential: Wednesday 20<sup>th</sup> November 2024 to Friday 22nd November 2024</u>

A provisional booking has been made for next year's Year 6 residential visit to Caythorpe Court in Lincolnshire. An information meeting for parents and children will be held on **Monday 15th January** 2024 at 3.40pm in Oak class. The meeting will last approximately 30 - 45 minutes and during this meeting there will be a short video, produced by PGL, for you to view which includes the type of activities, accommodation available and an explanation about the high level of safeguarding which the centre provides. After this staff will be available to answer any questions you may have.

Below is an approximate cost for you to consider for this residential trip

<u>The approximate cost</u> of the visit is likely to be <u>in the region of</u> £176.00 A 1.5% fee charged by sQuid will be included in the cost.

The cost of staying at Caythorpe is £156.00 per pupil but we are not able to provide an exact costing at this time because the price of the transport per pupil needs to be added and this is dependent on the number of pupils travelling. (coach costs are <u>an estimate</u> of £20 per pupil) Payments will be staggered after an initial deposit of £70.00

Pupils currently receiving Pupil Premium Funding will not have to send in any payment as the school will pay for these pupils using Pupil Premium. However, it is expected that all permission slips are signed and returned to school requesting the use of pupil premium funding to pay for the total cost of this residential trip.

If your child decides to commit to Caythorpe please be aware there is a cancellation policy set out by PGL which we, as a school, have to follow. This is stated below and found on their website. For those children in receipt of Pupil Premium Funding, parents/ carers will be expected to cover this cost <u>themselves</u> if their child decides to opt out after the initial deposit has been paid and up to and including the 14-0 days prior to commencement. This will include the payment of the deposit too.

## PGL terms and conditions

In the event you chose to cancel your PGL Adventure holiday, cancellation fees will apply, as follows:

Cancellation of residential:

- Up to 55 days prior to commencement Initial deposits retained (\*)
- 56 to 29 days prior to commencement 30% of the total price
- 28 to 15 days prior to commencement 45% of the total price
- 14 to 0 days prior to commencement 100% of the total price

(\*) Please note, if you pay the full balance at the time of booking these charges still apply, please refer to the deposits section for the deposit amounts.

A letter will be sent out after this initial meeting for you to confirm your child's place and payment can then be made via sQuid. The Caythorpe residential sQuid section will not be active until this confirmation of place letter is sent home.
